

**CLIFTON CAMPVILLE WITH THORPE CONSTANTINE PARISH COUNCIL**  
**MINUTES OF MEETING HELD ON 8<sup>th</sup> March 2023 @ 7pm**  
**In the Clifton Campville village hall**

3. **Members of the public & District Councillor**  
Mr & Mrs Tongue shared their concerns with members regarding planning applications for The Green Man. Although happy with pub renovations, their objections include the two new dwellings, loss of car parking spaces, settlement boundaries, conversion for shop and listed building.  
These objections were discussed at length and Mr & Mrs Tongue requested that the PC submit their own objections to the Planning Officer at LDC.  
Mrs Tongue asked District Cllr Yeates about a bus route for the village as a bus already travels down the Ashby Road and could go down the country lanes too. Cllr Yeates agreed to investigate this.  
Cllrs Yeates addressed members and explained that there have been lots of changes going on within LDC. There have been office spaces made available for commercial use giving an income and enabling more spending. This is all ongoing. Cllr Yeates commented on the forthcoming election and thanked the PC for all they have done.
